EVENT BRIEF

Deeksharambh" ---The Induction Programme of the batch of 2023

The Faculty of Law, SGT University organized "Deeksharambh" ------ the Induction Programme--- for the newly admitted students of the batch 2023 for the following programmes of BA LLB (H), BBA LLB(H), LLB(H)& LL.M. It commencedfrom 16 August 2023 and ended on 22 August 2023, spanning forsix consecutive days. The first day started with the inaugural ceremony, graced by the Chief Guest, Justice Manju Goel, former Judge of Delhi High Court, along with the Guest of Honour Prof. (Dr.) Shalini Sharma, an expert in economics and head of banking research at EGROW Foundation, NOIDA. Both of them addressed the students and wished them a bright legal career.

On the event's second day, the Organizing Committee took the students for a picnic at 'Rang Manch Farm.' On the third day, the faculty members briefed the various curricular activities and internship and placement programmesorganized by the Faculty of Law. The Dean of Student Welfare introduced the various extra-curricular activities organized by the University. There was a session titled "Show your Talent" for the freshers. On the fourth day, an expert Lecture was organized on "Legal Profession in



Present Era" by Adv. Savitri Pandey, a Supreme Court Bar Association member, and Dr. Vijay Aggarwal, an advocate at the Supreme Court of India, enlightened the students regarding scope and career growth in law. The faculty members of the Faculty of Law discussed the details of the examination system, the functioning of various committees, etc..

On the fifth day, an expert lecture was organized on "Heritage and Law" by Prof. (Dr.) Anamika Biswas, Consultant, Heritage & Museum Development, Archaeological Survey of India, Govt. of India. She guided the students regarding our rich heritage, related legal provisions, and career perspectives. Then, an event titled "Alumni Connect' was organized in which Mr. Khushal Saini, Advocate, Delhi High Court, an alumnus of the Faculty of Law, enlightened the students on "How to Prepare in Classroom for Court Room." The lecture demonstrated the symbiotic relationship between classroom learning and the courtroom experience. Mr. Khushal Saini explained how classroom learning helps in the Courtroom and its role in litigation.

On the sixth day of the induction programme, the organizing committee arranged a 'University tour' for the students to inform them of the different faculties, departments, and facilities available on campus. An Expert Lecture on "Drafting Skills and Pleading Under CPC, 1908"

He gave practical aspects of argumentation in the court of law, the basics of pleading in the court, and an overview of his experience with the clients and different







kinds of cases over the years. Advocate Mr. Gupta gave his second lecture with a historical perspective, tracing India's evolution of the Criminal Procedure Code(CPC). He highlighted its colonial roots and subsequent amendments. Ms. Monica Lochav, Assistant Professor, Faculty of Law, coordinated the lecture series.
